**A 2% interest will apply to all overdue accounts.**

**Due Date for Taxes is June 30<sup>th</sup> of the current year unless you have a payment plan set up**

**\*If taxes are paid in full by September 30<sup>th</sup>,2023 you will receive a 20% discount. This applies to all property, water/sewer, business, and poll taxes. This discount is only**

**for present year taxes and is only available for the 2023 year.**

**\* There will be no further adjustments to business tax for seasonal operations.**

**\* The seniors discount is discontinued**
